Duration, renewal, and termination

All our Contracts are evergreen and are subject to a minimum initial term of 12 months. After the expiry of the Initial Term the Contract shall continue in full force unless terminated by you.

If you terminate your broadband service after the end of the cooling-off period but during the first six months of the minimum term, you shall be liable to pay an early termination fee of €350. If you terminate in the second six months of the minimum term, you will be liable to pay an early termination fee of €160.

Upon cancellation of your Broadband Service, you must return all equipment to PrepayPower within 30 days of cancellation, failing which you will be liable for the value of the unrecoverable/damaged equipment in the amount of €86.10.
